Audit Report ending September 30, 2017

He presented final drafts to the trustees, this is an independent audit. Our administration's reported figures are in accordance with the standard practices. The financial highlights are very impressive – see page three (3)

The assets of the District exceeded its liabilities by \$1,845,327.00 at September 30, 2017. We are in a healthy financial situation.

Total expenses decreased \$9,614.00 in comparison to the previous year.

Total revenues increased \$70,721.00 in comparison to previous year.

We are operating in the black.

Our total net increased by \$138,727.00 for the year

Our deposits are held by a Qualified Public Depository financial institution.

We use good processes for accounting and our Internal Control over financial reporting are sound. There are no deficiencies.

We are experiencing no financial difficulties-As good as a report can get. We had no material errors in our report. An excellent report for a small operation.

Dick thanked Mr. Cramer for the report. Brent thanked Mr. Cramer also and asked for the process of an audit to be explained.

Mr Cramer first looks at internal control – risk control. He looks for assets lost if any. His work is done after our staff turns in their draft. The tax collector collects most of our revenue. Brent commented he would like the report earlier next year- Mr. Cramer said he would try. Dick – We are in excellent financial shape.
